WIRELESS INTERNET POLICY PERSONAL LAPTOP USERS

The Library provides free wireless high-speed Internet access for laptop users. Please be aware that there is no filtering software on our Internet connection. The library cannot monitor, control or endorse any information found on the Internet and is not responsible for its content, thoroughness, timeliness or accuracy. Users are advised to evaluate for themselves the validity of the information accessed on the Internet. Users are advised that because security is technically difficult to achieve, electronic communications and files could become public.

Wireless Internet users are expected to have a working knowledge of their laptop. We do provide a link on our website to help answer technical questions for wireless Internet access. At this time, laptop users will not have access to a printer.

Parents and guardians, not the library staff, are responsible for the Internet information selected and/or accessed by their children. Parents are strongly advised to supervise their children's Internet sessions. Unsupervised children may not access the Internet without a signed parental permission slip. This applies to anyone under eighteen (18) years of age.

- Wireless Internet users are **REQUIRED** to sign off on having read this policy manual.
- Wireless Internet users must sign in at the circulation date.

Wireless laptop users must adhere to the following guidelines. Failure to follow these guidelines may result in the suspension wireless Internet access.

- 1st Offense: 1 week suspension
- 2nd Offense: 1 month suspension
- 3rd Offense: 1 year suspension

Use of the library's wireless Internet connection for the transmission, dissemination and/or duplication of information are regulated under various state and federal laws. Wireless Internet users agree to indemnify and hold the library harmless for any and all claims arising out of their use of the wireless Internet access. All users will comply with such laws and regulations.

Situations not covered by policy will be handled by the library staff, Administrator, or Board of Trustees.
